Hi Tara,

If you recall from pre-COVID times, CFO Velasco and DC Herzog talked to you on 2/4/20 about needing to extend the interim contract with SRA for intelligence analyst services through the end of FY20. You had originally approved the interim contract through 3/1/20 but PD needs more time to complete the RFP so this extension was requested.

In a conference call, you gave the stipulation that PD was not to exceed the \$500,000 City Manager ETP limit for the fiscal year.

My staff released a change order to extend the contract to 9/30 and add the remaining anticipated FY20 funds, not to exceed \$500K, but that CO was rejected because it appeared to require City Council approval.

Can you please confirm in writing, for Munis documentation, that this extension is approved, and a CCL is not necessary?
